4. FIRST AID MEASURES

First aid measures

Eye contact Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye. Seek immediate medical attention/advice.

Protective equipment and precautions for firefighters

Precautions for safe handling

Conditions for safe storage, including any incompatibilities

Storage Conditions Keep containers tightly closed in a dry, cool and well-ventilated place. Keep from freezing. NFPA Class 1 oxidizers must be separated by at least 8 feet from incompatible materials and combustible commodities (NFPA 400 Table 15.3.2.2.2(A)(b) 2016 edition). Oxidizers need to be separated by at least 25 feet from flammable and combustible liquid containers. Separation shall be maintained by dikes, drains, or floor slopes to prevent flammable liquid leakage from encroaching on the separation (NFPA 400 15.2.12.13.1). At least one side of each pile of oxidizers shall be on an aisle (NFPA 400, 15.2.11.3 2016 edition).
