Quickly and effectively removes mineral stone which can harbor bacteria and compromise thermal efficiency of equipment. Phosphate free. FB-1559 may be used on equipment in all departments of dairy, meat, poultry, and general food processing plants.

Before use in federally inspected meat and poultry food processing plants and dairies, food products and packaging materials must be removed from room or carefully protected.
