## MEAT AND POULTRY PROCESSING ANTIMICROBIAL



### DANGER

**Fatal if inhaled. Causes severe skin burns and eye damage. May cause respiratory irritation.**  
**Prevention:** Do not breathe dusts or mists. Use only outdoors or in a well-ventilated area.

Apex Clear is a blend of sulfuric acid and sodium sulfate for use as an acidifier and antimicrobial solution in water spray, wash, or dip for meat and poultry processing. Approved in FSIS Directive 7120.1 (September 2020) and FDA GRAS Notice No. GRN 000408.

**DIRECTIONS FOR USE:** Prepare a 1% - 2% solution in water for a pH range of 1.2 – 1.6 to apply as a short spray/dip application of less than 10 seconds.

Wear respiratory protection. Wear protective gloves/protective clothing/eye protection/face protection. Wash face, hands and any exposed skin thoroughly after handling. **Response:** Specific treatment is urgent (see Section 4 on SDS). Immediately call a poison center or doctor. **IF IN EYES:** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a poison center or doctor. **IF ON SKIN (or hair):** Take off immediately all contaminated clothing. Rinse skin with water/shower. Wash contaminated clothing before reuse. **IF INHALED:** Remove person to fresh air and keep comfortable for breathing. Immediately call a poison center or doctor. **IF SWALLOWED:** Rinse mouth. DO NOT induce vomiting.  
**Storage:** Store in a well-ventilated place. Keep container tightly closed. Store locked up.  
**Disposal:** Dispose of contents/container to an approved waste disposal plant.

**STORAGE AND SHELF-LIFE:** Store in a secure well-ventilated area. Recommend storage in closed building/warehouse to protect from environmental elements. Protect from extreme temperatures of <10°F and >100°F. Keep containers closed when not in use. New/unopened containers are stable for 3 years. Open containers are good for 1 year as long as protected from the elements and stored in accordance with storage instructions.
